

## LIMITED WARRANTY

KERA Technology, at its sole election, will repair, replace or refund original purchase price for the defective product free of charge within the warranty period only if product was installed and used according to the specifications and if it is delivered or shipped to KERA freight and insurance prepaid together with a copy of proof of purchase and completed warranty card.

This limited warranty does not include cleaning or any damage caused by accident, neglect, misuse and ceases when product is sold, rented or otherwise disposed of to a third party.
